EVALUATION CRITERIA

An interdisciplinary team of FSJD and HSJD will assess the different proposals submitted. This will be formed by:

- Social Innovation Officer
- Project Coordinator and PI of RESCCUE4COVID
- Head of the Community Mental Health Area for children and adolescents.

The expertise and the proposal of activities will be evaluated together. The maximum score for every aspect will be:

- Curriculum of expertise of the institution with gamified interventions: 5 points
- Case studies with similar content: 5 points
- Creation and validation process: 10 points
- Budget: 5 points

Only the proposals which achieve at least 20 points will be considered as candidates to perform the activities of this contract. The best creative process proposal with the fairest budget will be selected.

FINAL DECISION

One proposal has been submitted for this tender. The evaluation committee considers that the proposal submitted by MARINVA covers all the requirements requested in the tender.

MARINVA is an expert in gamification with proven experience in the educational sector. They also have proven experience in collaborative processes of co-creation and validation which is indispensable for this project.

They offer a multidisciplinary team that can help the project's team to further conceptualize the resources and bring the ideas to life. The proposal includes a thorough description of the action and it already provides the creation path to be followed. It also includes examples of their past work that specifically relates to the themes and content of our project.

Overall, MARINVA has submitted a good quality proposal with a fair budget.


Therefore, we recommend that the WP2 Co-creation of digital and collaborative resources for the project be awarded to MARINVA at the bid price of 16.550€.
