To honor excellence in research concerning the physiology or biology of healthy skin and /or its reactions to environmental factors.

### AWARD CRITERIA

1. The CHANEL-CERIES Research Award supported by CHANEL Research and Technology is intended to honor the accomplishments of a researcher and to encourage his or her continued research activity. The field of research may be fundamental or clinical in nature and must concern the physiology or biology of **healthy skin** and/or its reactions to environmental factors. Projects focused on skin diseases will not be considered. The money granted must be used to accomplish the described research project.
2. Applicants should have a proven track record in the field of research, including the subject area of proposed research.
3. Applications must be typed in English and include:
  - the candidate's curriculum vitae (maximum 3 pages) and photo
  - a summary of the candidate's current research
  - a description of his or her projected research
  - a signed copy of the award conditions
4. Work may be performed at any hospital, university or other not-for-profit research laboratory.
5. The applications for the CHANEL-CERIES Research Award will be reviewed by a panel of experts. The jury's decision will be final and without appeal.
6. The selection process will take into account the following criteria: the quality and quantity of published research, professional recognition, evidence of sustained interest in the Award's intended scope of research, and the quality of the applicant's research proposal. Projects involving animal research are discouraged.
7. The awardee will be selected in June 2016. Only one Award will be granted. Award funding will be disbursed to the host institution in one single payment which will be made at the latest on September 30, 2016. The recipient will be personally notified of the decision to award him or her the CHANEL-CERIES Research Award.

## INSTRUCTIONS TO APPLICANTS

- GENERAL:** Applications must be typed in English. The jury cannot accept unclear applications or applications where information is missing.
- CURRICULUM VITAE:** Should contain: photo, name, date of birth, nationality, home address and telephone number, business address with telephone and e-mail address, education and training, current and past professional positions, selected publications. No more than 3 pages.
- RESEARCH FUNDING:** List of current grants, stating if the applicant is Principle Investigator and including any funding for the proposed project.
- PUBLICATIONS:** List of 10 most important papers (preferably papers published in the past five years) and the total number of citations to date.
- IMPACT FACTOR:** Journal impact factor (in the year of publication) for each of the above ten papers.
- RECENT & CURRENT RESEARCH INTERESTS:** Listed on 1 page.
- AWARD RESEARCH PROPOSAL:** On 3 pages:
- Title
  - Background
  - Hypothesis
  - Specific aims
  - Approach and methodology
  - References
- SIGNATURE:** With your signature you agree to the conditions specified for the CHANEL-CERIES Research Award.

## **AWARD CONDITIONS - *to be signed and returned with applications***

An official announcement of the awardee will be made in the press. The awardee accepts that his or her name as well as the object of the research will be mentioned in the press on this occasion.

CHANEL Research and Technology should be kept informed of all publications deriving from the Award sponsored research.

The recipient agrees to acknowledge CHANEL Research and Technology in his or her scientific publications deriving from the funded research with the following phrase: "The researcher is a recipient of the CHANEL-CERIES Research Award".

The funded research may be presented to the press by CHANEL Research and Technology or the recipient him or herself in partnership with CHANEL Research and Technology.

If requested by CHANEL Research and Technology, the recipient will present the funded work, in written or oral form, at in in-house meeting or a CHANEL sponsored event. Travel and accommodation expenses incurred by the awardee in connection with this presentation will be reimbursed, on the condition that such expenses will have been previously approved in writing by the CHANEL Research and Technology.
